Dear Mr. President:

As the leaders of American manufacturing, agriculture and energy industries and some of the nation's largest freight rail customers, we urge you to move forward to nominate new members and a permanent Chair to serve on the Surface Transportation Board (STB). We need a fully-staffed STB committed to moving forward on freight rail policy reforms that will streamline overly burdensome regulatory procedures and promote greater competition in the rail sector.

Our organizations, including trade associations and individual companies, represent a broad cross section of industries that provide more than 7 million direct jobs and support millions more throughout the United States, and generate trillions of dollars in economic output each year. We depend on the railroads to deliver reliable and affordable service in order to remain competitive in a global market.

Competition is the foundation of the free enterprise system and helps American producers grow their businesses, generate new investments and create jobs. However, many freight rail customers have no effective competition for transportation service. The STB plays a critically important role in resolving rail rate and service issues where competition is lacking.

Congress unanimously passed the STB Reauthorization Act of 2015 to help improve how the STB operates, and the Board has initiated a number of steps to modernize overly burdensome procedures. These reforms are aligned with the pro-growth goals of your administration for many important sectors of the U.S. economy; they will help ensure that commodities, including grain, coal, minerals, energy, fertilizer, forest products, steel, and manufactured goods, can be shipped efficiently to both domestic and international markets. Unfortunately, with only two of the five STB positions filled and no permanent Chair, progress on many of these overdue regulatory reforms has stalled.

In order to regain momentum and support U.S. businesses, we must be sure that the STB is fully staffed and comprised of members that will make decisions based on current economic realities and founded on free market solutions. In addition, it is imperative both for railroads and for their customers to have confidence that the STB is a fair and unbiased arbiter of disputes. Therefore, we strongly discourage naming rail industry veterans to the Board, especially as Chair.

We welcome further discussion with you on these important nominations, and look forward to working with your Administration on policies that support growth across the entire U.S. economy.
